### December 2011 Scout Family Ski Days

Many of you attended one or both of our last December's two big Scout Family Ski Days at Copper Mountain Resort. We had over 5200 participants last year! We have scheduled the same two great days for this December, as follows:

Saturday, December 10, 2011

Saturday, December 17, 2011

The price is \$30 for any age. Note: Increase in price is due to changes in food source and serving by Copper Mountain Resort.

This includes lift ticket and breakfast and a big lunch in the beautiful Village Square Meeting Rooms. We'll have exclusive use of this center the entire day, and will have helpers there from 8:00 a.m. throughout both days to answer questions, etc.

I will get the ski tickets about November 10, and they'll only be good ONE day on either Saturday, December 10, or Saturday, December 17, 2011. They will not be good any other day. I will have tickets available anytime between November 10 and December 17th. The ski ticket from me is the actual lift ticket that you'll wear on the hill so be careful not to lose it.

Remember that Copper Mountain does the best job of snow making and grooming. They have a large reserve of water on hand for snowmaking. Most runs are 3-stage groomed every night. Skiing on a freshly groomed run of man-made snow is very nearly as good as on natural snow. But we feel that good natural snows will have arrived by these December days; we had great natural snow by early December last year.

For best and safest beginner skiing/boarding, we strongly suggest:

December 10 – Use the short Green Acres Lift (150 yards east of Eagle Lift). After 3 or 4 runs here, you could possibly go up Flyer Lift or Timberline Lift (from the top of Flyer Lift).

December 17: Go to Union Creek (now called “West Village” - west of resort). This opens this weekend. Take the shuttle there from the Alpine Lot or from the Village Center (at the Village Square Meeting Rooms).

I'll need payment by cash or check written to me. See the attached form and information sheets. But remember, I'll have the tickets at my house so get in touch with me as soon as possible. Please talk it up so that we'll have great turnouts.

Important Note: I am at the same address as last year (still in Centennial area). Easy access from I-25, C-470, etc. (see attached map). Same Telephone number too: Richard Hansen: 720-493-9498.

\*\*\*\* Please include notice of this event in your unit or ward bulletins. It is of course open to young ladies as well as young men (adults too). It is important to assign someone to handle the ticket requests for your group as logistically I cannot speak with everyone.

\*\*\* “West Village” (the area mainly for beginners) will not be open December 10<sup>th</sup>. It will be open on December 17<sup>th</sup> however. The brand new high speed “Union Creek” quad lift replaces the old “High Point” lift!! The “Kokomo” and “Lumberjack” beginner lifts remain the same.

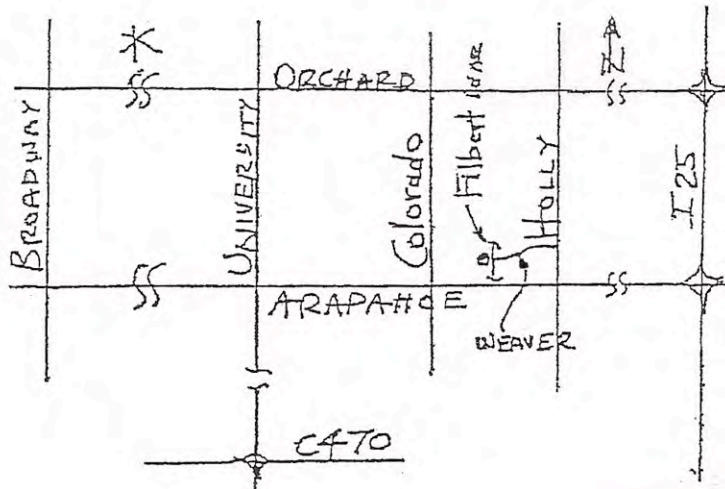

# Scout Family Ski Days and Snowboard Days

## Saturday, December 10, 2011 and Saturday, December 17, 2011

Richard Hansen is the volunteer chairman and will have tickets. Call him in advance to get tickets. Richard has been chairman these last 15 years. We had over 5200 participants at these two events last year.

1. Ski and snowboard rentals are available at any one of the [5 Breeze Front Range locations](#). Call in advance to reserve your rentals. Say you are with Scout Family Ski Days. These prices are available to us for the two days (December 10 and December 17<sup>th</sup>). Rentals may be returned as late as 9:00 p.m. same day or by 9:00 a.m. the following day.

**Skis, boots, and poles:** \$9.99 (regular package) (New Shaped skis!) or \$17.99 (Performance package)

**Snowboard and boots package:** Junior (Max. size 5 boot) \$9.99; Regular \$15.99.

For groups of 10 or more renting, call 303-338-6423, 4 days prior to renting.

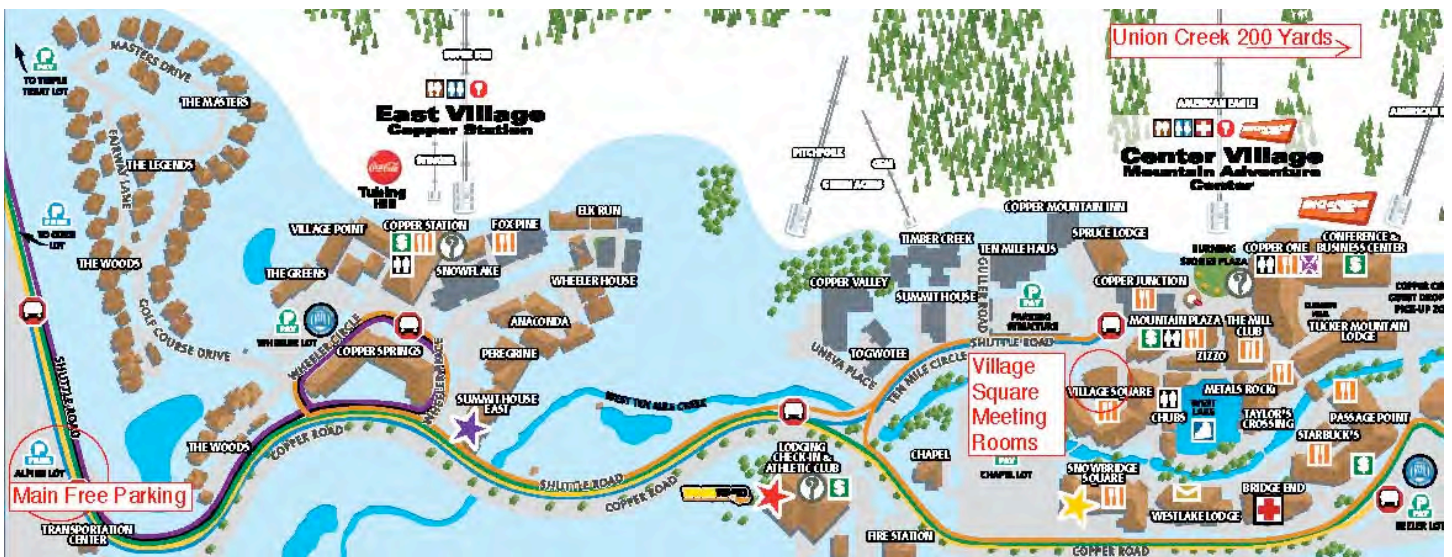
Eskimo Shop (Holly & County Line Rd) 303-761-1101 and many Sports Authority stores will honor these rental prices. (Call them).

2. If you are renting skis or boards for the December 10 or December 17<sup>th</sup> days, it is very important that you go to [Breeze](#), Eskimo Shop or Sports Authority the Tuesday or Wednesday of that week to reserve your equipment. This is especially true if you have more than 6 or 7 in your group renting.
3. To get to Copper Mountain Resort, exit I-70 at the Leadville/Copper exit. (Highway 91). Regarding where to park at the resort, you have two main choices, as follows:

**Free Parking:** at the huge “Alpine Lot.” It is off Highway 91 about ¼ mile south of the resort entrance. Take the free shuttle marked “Village Center” (Ten Mile Circle). This stops right at the Village Square Meeting Room (just 30 yards north up the small stairs). Shuttle every 10 minutes.

**Pay parking:** Best is the “Chapel Parking Lot. \$20.00. Drive about ½ mile in from the resort Entrance. The Village Square Meeting Rooms are just across the bridge on the west side of the Lot.

We suggest you arrive early (by 8:00 a.m.) to get the best parking. We also recommend that you leave the Denver area by about 6:00 a.m.



**IMPORTANT: THIS IS A LEGAL DOCUMENT**

Skiing is not without risk. The same elements that contribute to the unique character of a skiing experience, riding ski lifts, going downhill, other skiers, and the winter environment, can cause loss or damage to equipment, accidental injury to participants, illness, or in extreme cases, permanent trauma or death. We don't want to heighten or reduce your enthusiasm for the experience, but we do want you to know in advance what to expect, and to be informed of the various possibilities. We ask that you read this, sign it, and return it to "Scout Family Ski Days" with your registration. If you have any questions regarding the "Acknowledgement of Risk", please do not hesitate to ask us about it.

Under Colorado law, a skier assumes the risk of any injury to person or property resulting from any of the inherent dangers and risks of skiing and may not recover from any ski area operator for any injury resulting from any of the inherent dangers and risks of skiing, including: changing weather conditions; existing and changing snow conditions; bare spots; rocks; stumps; trees; collisions with natural objects, man-made objects, or other skiers; variations in terrain; and the failure of skiers to ski within their own abilities.

**ACKNOWLEDGEMENT OF RISK**

I certify that I and my family, including minor children, are fully capable of participating in the ski trip. I herein state that I have read the above statement on the possible risks in this activity. Therefore, I assume full responsibility for myself, my family, including minor children, for bodily injury, death and loss of personal property and expenses thereof as a result of my negligence or the negligence of my family participating in the ski trip. My son/daughter is in good physical condition and able to undertake this activity.

**CONTACT, WAIVER AND RELEASE**

It is up to each local youth group and/or parents of all attending youths considering the risks involved, to participate in this fun money-saving ski program. This of course, includes their acceptance of the risk of travel to and from the resort.

We ask that each church or youth group have a leader "HERO" who arranges a time to bring the completed registration forms and accompanying checks (\$30 per ticket) to Richard Hansen's home prior to the event to pick up the lift tickets. Each "HERO" must also provide an emergency telephone contact list for each of their participants. Keep this list available at the resort.
